#### E. New Business

- 1) Pastor's Report: The Confirmation and Wednesday School schedules are winding down. Pastor plans to meet with next fall's 10<sup>th</sup> graders as they prepare for Confirmation. There are about 3 students in the group. Rene and Pastor plan to attend the Synod Gathering in Fergus Falls
- 2) Vice President's Report: Orrin applied grass seed, fertilizer and weed-kill in the front of the church; plants will need to be added at some point. Discussion continues on how to increase membership and youth involvement.
- 3) Property Update: Evie reported sewer line has been repaired but there may need to be more work in the future as the line is aged. The State will again inspect the elevator once the fire

- alarm wiring is complete. The echoing sound during broadcasts seems to have been alleviated. The committee is looking at washing the exterior of the church in such a way that the stucco isn't damaged.
- 4) Mission Update: Connie stated that about \$250 has been raised thus far for Valley Lake Boy's Home, the May Mission. Kinship will be recognized in June. She plans to meet with Deb, Jill and Lois to discuss evangelism ideas.
- 5) Youth Education Report: Joel reported that the committee has discussed ways to incorporate the youth into Faith, Care and Share. A trip to Valley Fair is planned for June 9<sup>th</sup> and a Pool Party is set for August 2<sup>nd</sup> or August 9<sup>th</sup>. There was a meeting with parents of youth interested in attending the National Youth Gathering to be held in New Orleans. VBS is set for the first week of August at Bethel. Activities around Headwaters are being considered.
- 6) Financial Update: Questions about donating Facebook/garage sale profits to the Mission Debt Reduction can be directed to Orrin or Jill.
- 7) Worship Update: The committee has made plans for summer worship.
- F. Church Pulse: Interest was expressed on scheduling a trip to a Twins game. Evie will make some inquiries.
